

Guidelines for Submitting Articles

Online Submission

Ethics

Aerospace & Defense publishes only original articles. All parties involved in the publication process, including authors, editors, and reviewers, are required to adhere to the ethical guidelines for research and publication of scientific articles.

Article Length

Articles are limited to 5,000 words, excluding references, footnotes, tables, and figures.

Language

Aerospace & Defense is a bilingual journal: each issue is published simultaneously in English and Hebrew on our website and distributed to our readers. The journal provides professional translation for every article accepted for publication.

Preparing the Article

- **Numbering:** Number all pages consecutively at the bottom of the page, excluding the title page.
- **Font:** Use Times New Roman, size 12, with 1.5 line spacing and standard margins of 2 cm.
- **Citations:** in-text citations in the text and include a reference list according to APA 7th edition style. The APA citation guide can be found at the following link: [APA Citation Guide](#)
 - Use Capitalized letters for professional terminology.
 - Use *Italics* for Quotes.
 - When quoting a book or article, indicate the exact location, including the page number from which the quote is taken.
 - Quotes longer than 40 words should be in a separate paragraph with indentation.
- **Footnotes:** Use automatic numbering at the bottom of the relevant page. Footnotes may be used for (a) explanation, (b) citation from sources with limited availability, (c) adding information presented in a table or figure. Use them sparingly and avoid long footnotes.
- **Reference List (Bibliography):** I alphabetical order. Sources of information that are not in English should include a transcription in the original language.
- **Chapter and Subchapter Titles:**
 - First-level title (size 16, bold, left-aligned)
 - Second-level title (size 14, bold, left-aligned)
 - Third-level title (italics, underlined, size 14, left-aligned)

- **Dates:** For example, 6 February 2012.
- **Years/Numbers:** For example, 1998-2006, 13-18.
- **Abbreviations and Acronyms:** Limit the use to common and necessary abbreviations. Immediately after the full term, include the abbreviation in parentheses.
- **Permissions**
To include illustrations, tables, and excerpts previously published elsewhere, authors must obtain permission from the respective copyright holders and provide documentation of such permission at the time of submission, applicable to both the printed and online editions.

Submitting the Article

Articles are published after a double-blind peer review process. Remove any identifying details of the author from the article and attach only two files:

1. **Title Page File:** One page including the following details:
 - Article title
 - Name of the author(s), including organizational affiliation, phone number, and email address for each.
 - Name of the contact person for correspondence and updates from the journal system.
 - A short biography of each author (up to 2 lines).
 - Total word count of the article (excluding references, footnotes, tables, and figures).
 - 4-6 keywords.
2. **Article File:** Remove any identifying details of the author from the article. Additionally:
 - The article should include a title, followed by an abstract of 150-250 words.
 - The article file should include all required sections (Introduction, Methods, Results, Conclusions, and References).
 - Figures and tables should include captions and explanations and be attached in a separate file.
 - Only articles in an open file format (MS Word) will be accepted for review.
 - Articles that do not meet these criteria will be returned to the sender for correction.
